#### **G. NEW BUSINESS**

##### **1. HEALTHY EATING, ACTIVE LIVING CITY INITIATIVE**

Teri Angel, Recreation Services Manager, presented information regarding the League of California Cities' Healthy Eating Active Living Cities Campaign, and requested the Commission's support in the City taking part in the program.

Commissioners gave suggestions on health related programs already existing in the Beverly Hills Community which they believe would qualify the City to be part of this program. Ms. Angel took note of the suggestions, and stated that she will return to a future meeting with a draft of a resolution for the commission to review.

##### **2. NEIGHBORHOOD WATCH PROGRAM**

Sgt. Gregg Mader was unable to attend the meeting due to a family emergency. Director Mottice Muller noted that she will invite Sgt. Mader to



attend the March meeting to discuss the possibility of holding National Night Out again in 2012.

3. STAKEHOLDER SUMMIT

Director Mottice Muller reviewed information on the planning, logistics and outreach for the event.

Director Mottice Muller also passed out a list of businesses, community and faith based organizations which were sent save the date cards. Commissioners were asked to make note of any organization which may have been left off the list so that they could be contacted and invited.

4. CERT UPDATE

Director Mottice Muller noted that Commissioners Landau and Seidel attended a training class which certified them to be CERT instructors.

Director Mottice Muller explained the various aspects of what is involved in administering a CERT training and also a program. In the future, staff will ask the City Council to reinstate the training and program. Commissioners agreed to support the reinstatement of the CERT program.

5. MONTHLY HEALTH AND SAFETY MESSAGES

Chair Judelson suggested the following messages for March to be placed on the City AM Radio station:

- Drivers and cyclists slow down in rain or when visibility is reduced
- Be sure to cross the street at a designated crosswalk. No jaywalking! Look right and left before crossing. Make eye contact with drivers before crossing. Don't assume that because you can see the driver, the driver can see you.

Commissioner Aronberg suggested the following messages that will be placed on the City's social media outlets:

- a safe workplace is no accident,
- light home entrances, and
- when using social media, keep your status updates safe (don't say that you're out of town/not at home).

6. HEALTH AND SAFETY AWARDS

Commissioners discussed the possibility of changing the format of the health and safety awards from the previous year. Commissioners agreed that the timing of the awards is difficult to determine, and eliminate the application process and the awardees should be chosen on an ad hoc basis, both nominated and chosen by Commissioners.

The theme for 2012, "A Healthier LA County Begins Today: Join the Movement!" was developed to encourage community residents to take preventive measures to help improve their lives.

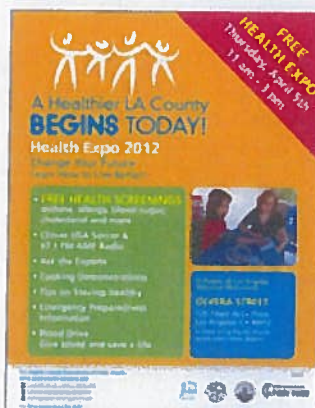

**INTRODUCTION**

The Healthy Eating Active Living (HEAL) Campaign is a partnership composed of the League of California Cities, California Center for Public Health Advocacy, and the Cities, Counties, and Schools Partnership. The purpose of the HEAL Campaign is to provide training and technical assistance to city officials to adopt policies to improve their community's physical activity and food environments. The City's General Plan and the current programs and practices of the City embrace the requirements of the HEAL Campaign. At the February Health and Safety meeting the Commission provided input and support of the program and the development of a resolution to take to the City Council for approval. Teri Angel, Recreation Manager is seeking your input of the resolution. Your suggestions were incorporated into the list of ways the City supports this initiative.

**DISCUSSION**

In 2004, the League of California Cities adopted an Annual Conference Resolution to encourage cities to embrace policies that facilitate activities to promote healthier lifestyles and communities, including healthy diet and nutrition, and to adopt city design and planning principles that enable citizens of all ages and abilities to undertake exercise. In 2006, the League adopted a resolution to work with the Institute for Local Government and the Cities, Counties and School Partnership to develop a clearinghouse of information that cities used to promote wellness policies and healthier cities, the response to which is the HEAL Campaign. HEAL Campaign staff, under the guidance of an advisory committee of elected and executive staff leaders from 20 cities, reviewed survey responses from over 100 California cities to adopt one or more of these policies to become a HEAL City. The policies identified by the HEAL Campaign staff fall under three general categories:

1. Land Use
2. Availability of Healthy Food Choices, and
3. Employee Wellness.

The City of Beverly Hills demonstrates commitment to many of the policies advocated through the HEAL Campaign. The HEAL Campaign was presented to both the Health and Safety Commission and the Recreation and Parks Commission at their February meetings and both unanimously endorsed the resolution to become a healthy City. The City qualifies to become a

**SUBJECT:** LA Marathon Update

Staff and Commissioner Landau will provide an update on the City's involvement in the LA Marathon in particular the opening of the EOC and the use of DCS and other volunteers.

A couple of facts:

- EOC opened at 5:00 am with the overall goal to protect the health and safety of all spectators and participants and to assist in the coordination of the event,
- an Event Action Plan and an EOC Action Plan had been completed,
- the telephone notification system was used to notify all white page and opted in users that roads were to be closed,
- hotline opened at 6:15 am,
- used same hotline # as would use in a disaster 310-550-4680,
- hotline received over 125 calls (225 calls last year),
- 24 paid and volunteer staff worked in the EOC, radio room and disaster hotline,
- approximately 170 total staff worked the event,
- police department was the lead agency for Operations,
- other departments and divisions represented in EOC were public works, fire department, community services, and city's manager's office,
- members of DCS were used in the EOC Radio Room to monitor PD, FD, local govt. and DCS radio frequencies,
- members of DCS were used to staff road closures,
- Twitter, Nixle, and Facebook were used to update users on the road closures,
- mobile cameras were deployed and the EOC had the ability to view various locations through the City and along the marathon route,
- WEB EOC was used by the EOC and by the MACC in Los Angeles to provide information, track and manage event
- 1 transport in City and total 11 overall,
- north/south access was available by 1:00 p.m., and all roads in Beverly Hills were opened by 1:30 pm,
- EOC was deactivated by 1:43 pm, and
- the LA Marathon, a private enterprise, pays for all of the permits, fees, and personnel costs related to this event.
