1) PUBLIC COMMENT

Members of the public were given the opportunity to directly address the Committee on any item listed on the agenda.

2) BEVERLY HILLS COMMUNITY DOG PARK UPDATE

Management Analyst Stephanie Harris updated staff on the Beverly Hills Community Dog Park after 6 months of operation, providing information on park usage, the registration process, the Park Rangers who oversee the site, and Recreation and Parks Commission recommendations.

- The trees are maturing offering more shade.
- Umbrellas are being set up, behind the benches so not to be in the way of patrons nor dogs.

It was agreed:

- Based on Recreation and Parks Commission recommendations, it was agreed to extend the current procedures until the end of summer which will have retained the test policy for a full year.
- After September, outreach and discussion on the current Dog Park usage policies and continued Park Ranger supervision.

- Direct any Park Ranger complaints to James Latta.

3) CITY COUNCIL PRIORITY – MASTER PLAN CITY NEEDS AT LA CIENEGA PARK & TENNIS CENTER SITE

Director of Community Services Nancy Hunt-Coffey requested direction on the City Council's Priority of Master Plan City Needs at La Cienega Park & the Tennis Center Site.

Staff was directed to develop another public outreach process to ascertain the community needs at this location.

4) BEVERLY GARDENS PARK RESTROOM OPTIONS

After decades of usage, the restroom building at Block 13 of the Beverly Gardens Park needs to be renovated. Via the City's bid process, the accepted lowest bid was \$200,000 more than the proposed budget.

Council Liaisons advised Staff to bring the item for discussion to the June 13, 2017 City Council Meeting.

5) QR CODE REQUEST

Members of the Beverly Hills Historical Society Robert Anderson and Phil Savenick, provided a demo of their QR project that when activated on your phone, the QRCode would show old photos and information at certain City locations. This could be used in collaboration with the Beverly Hills Public Art application.

The members requested approval to test two sites: Beverly Gardens Park and Will Rogers Park.

The Liaisons directed Staff to bring the information to the June 13, 2017 City Council Study Session.
