1) PUBLIC COMMENT

2) BEVERLY HILLS COMMUNITY DOG PARK UPDATE

Senior Management Analyst Stephanie Harris updated staff on the second park survey following a year of operation to obtain further information to assist with recommendations for presentation to City Council in October. Two Hundred fifty (250) responses were received and will be presented at the Recreation and Parks Commission meeting on September 26, 2017. Survey results were provided on the following: Park usage, Registration Process and Park Rangers.

Recommendations included: research of temporary shade options and key card process, limited non-resident use, and reduction in Park Ranger hours.

3) COLDWATER CANYON PARK PLAYGROUND RENOVATION

Recreation Services Manager Teri Angel updated Council Liaisons on the process and decisions on the design renovation of Coldwater Canyon Park playground. The Recreation and Parks Commission will be reviewing the final proposed design plans at their September 26, 2017 meeting.

The proposed design will be forwarded to the City Council Liaisons prior to being presented to City Council at an October meeting.
